

Equine Therapeutic Shoeing – 1 week clinic

Doug Russo CJF, AWCF will be offering 1-week clinics focused on therapeutic equine shoeing. Clinics are located at Iowa State University's Lloyd Veterinary Medical Center Large Animal Hospital. Clinics will be limited to 3 students and will be closely tailored to student needs and interests. Clinics will include understanding the role of diagnostic imaging such as radiography, ultrasound and MRI in equine lameness. Students will spend time with the Iowa State University equine surgery team to observe lameness exams and to learn about surgical intervention that requires farrier support. Additional coursework includes studying and understanding distal limb anatomy, biomechanics, pathology and therapeutic shoeing protocol. There will be a focus on forging therapeutic shoes. Students will be able to observe cases that are treated by ISU's equine surgery/farrier team. This is an excellent opportunity to improve your ability to provide support for your area's veterinarians as well as improve skills and service to your shoeing clientele. This would be useful information for those preparing for the AFA's therapeutic endorsement and the Associates with the Worshipful Company of Farriers.

American Farrier's Association Certification Prep Clinic – 1 week clinic

Doug Russo CJF, AWCF will be offering 1-week preparatory clinics for those interested in taking the American Farrier's Association certification. Both the Certified Farrier and Certified Journeyman Farrier's levels will be covered. Class size is limited to 3 students and will be closely tailored to student needs and area of interest. Clinics will focus on forging, time management, understanding certification, understanding the score sheet, study techniques as well as lectures and clinician lead group study.

The farrier courses are located in the Performance Evaluation Facility at the Large Animal Hospital, Lloyd Veterinary Medical Center in Ames, Iowa.
